CNCF – Director’s Report, Associate Professor Craig Lockwood

With the end of year rapidly approaching, it is natural that our attention turns to 2017, as well as to what has been achieved in 2016. Looking back over this year we can see there has been a massive amount of work, and the outcome of the activity you have been contributing to has established a strong global presence for the Nursing Care Field.

Some of the Field’s remarkable achievements include:

- The continuation of the review tagging project,

- The re-naming of the CNCF (Cochrane Nursing Care),
- The establishment of a new template for Cochrane Corners to increase the profile and international recognition for Cochrane Nursing Care to disseminate Cochrane Evidence,

- The integration of Cochrane Central messaging in our own updates and messaging to members,
- The highly regarded series of case studies that report the experiences of Cochrane Nursing Care contributors, these have become a key impact message which the Cochrane Central Executive have noted, among other achievements.

I would like to start by expressing appreciation for the leadership of Alex Mignone in providing a point of contact and maintaining a huge program of Cochrane Corners over 2016, including establishing contracts with new journals that will greatly increase the visibility and impact of authorship of each Cochrane Corner. As the Field Coordinator, Alex has been your central point of contact, as well as writing and maintaining our newsletter, and meeting the requirements of publication schedules for national and international journals over 2016 – and I am delighted to be continuing to work with Alex in 2017.

Over the last few years, Cochrane has undertaken a massive review of its structure and function; this has included extensive stakeholder engagement as well as consultation with groups, entities and

individuals who volunteer their time to support Cochrane's mission and activities. Cochrane Nursing Care has been recognised for its decentralised structure and efficient operational processes. The 'Hub and Spoke' model used to facilitate collaboration and activity has enabled the field to be successful operationally and to engage widely without external funding. The Joanna Briggs Institute remains committed to supporting the Field and will continue to do so in 2017, but it is you who we really want to thank!

Without your willingness to volunteer time, expertise and support, Cochrane Nursing Care would not have been able to engage with the International Nursing community, would not have been able to increase access to, and accessibility of Cochrane evidence, and would not have been able to introduce many nurses to Cochrane tools, resources and evidence.

Some of you have also been involved in the structure and function review, and have contributed feedback. On behalf of Cochrane Nursing, thank you for supporting and assisting to inform the review. I am pleased to say it is almost complete, and there are several key documents that have now been released for public access which will make valuable and important reading for anyone who is considering engaging with Cochrane Nursing Care in 2017 or beyond.

On the above site you will find the strategy, and additional documents related to facilitating and resourcing the strategy. This year I have been on a working group that

helped to establish the strategy and this work will conclude in mid-2017 – although all Cochrane groups are encouraged to read, prepare and consider how they might support the KT strategy.

The second key document is based upon the KT strategy, and that is the Fields Structure and Function review proposal. This document completely transforms the mission, scope of operations and level of stakeholder engagement and consultation for Cochrane Fields. It is in active discussion now, with a sub-group of the Fields executive working on a strategy for implementation that will be presented in Geneva, 2017. This document, when complete will be the trigger for a complete review of Cochrane Nursing Care, some activities we have maintained in the past will no longer be a core program activity, while activities that are outward facing and lead to greater engagement with individuals, societies, associations as well as professional and peak bodies to facilitate KT will have far greater prominence! Over the past 12 months, the CNCF has prepared and published in excess of 100 summaries on Cochrane reviews. This is an immense achievement for the Field and has had a significant impact on the global dissemination of Cochrane evidence. But the Field does not operate in a vacuum, so I would like to echo the words of our Field's Director and take this opportunity to thank and acknowledge those many professionals who have played an integral part in ensuring the CNCF meets the objectives of its mandate.

CNCF Teleconference to Discuss Field's Activity in 2017

Over 2016 the CNCF Director, Associate Professor Craig Lockwood, has been involved in a series of teleconferences for the Cochrane Nursing Care Field. The

Fields, along with all Cochrane entities, are undergoing a review of structure and function. These conference calls with the Field's Executive Group are meetings of the working party that will undertake the review process for the Fields, supported by the Cochrane Central Executive. Associate Professor Lockwood is a member of this working party, which will provide recommendations to the Cochrane Steering Group in early 2017.

CNCF establishes publication agreement with UK's best-selling nursing journal



The CNCF is delighted to announce the establishment of a new publication agreement with the 'Nursing Standard', a periodical currently regarded as the UK's best-selling nursing journal.

The Nursing Standard brings its subscribers comprehensive coverage of leading clinical practice, research articles, and topics on continuing professional development, in addition to information and updates on critical developments in the nursing profession.

After becoming aware about the mission of the CNCF in the dissemination of best practice evidence in nursing care, the Nursing Standard initiated contact with our Field's Executive and proposed a collaboration for the regular publication of a 'Cochrane Corner'. The terms of the agreement have been settled, with

publication of the Field's summaries in this journal to commence in 2017.

Changes to the Cochrane Library in 2017

Cochrane are currently developing various enhancements to their Library that will provide greater functionality, making it easier for users to discover and use Cochrane content in their decision-making.

The first changes will roll out in early 2017 and include: enhancements to the display and new features for Cochrane Reviews and other articles; enhancements to CENTRAL; linking of the CDSR and CENTRAL; an improved search and discovery interface.

The Cochrane Library will maintain its familiar look-and-feel while improving the overall user experience. Researching user needs and stakeholder insights is a key component of development, and Cochrane are doing this research through one-to-one user testing with their Library users, and focus groups with members of the Cochrane community.

Reducing research waste – A message from the Cochrane Community

An estimated \$170 billion of research funding is wasted each year worldwide because its outcomes cannot be used. The waste occurs during 5 stages of research production: question selection, study design, research conduct, publication, and reporting. Much of this waste appears to be avoidable or remediable, but there are few proposed solutions.

In an effort to address this problem, Cochrane developed a survey that was given to a group of professionals who attended the Research Waste/EQUATOR Conference (Edinburg 2015), and who are involved in one or more of the Cochrane Groups. They were asked what Cochrane

could do to reduce this waste problem and support the Reward Alliance. The key outcomes for the survey were 1) Support priority setting processes for systematic reviews 2) Advocate for systematic reviews with funding organisations 3) Speed up the 'empty review' process 4) Work with partners to strengthen reporting of research 5) Automate the review process.
